SECTION THREE: ELIGIBILITY CRITERIA FOR MEMBERSHIP IN THE CORPORATION

A Member of the Corporation of Community Living Ajax-Pickering and Whitby must:

- (i) be a person eighteen (18) years of age or older.
- (ii) endorse the mission, vision and values of the Corporation.
- (iii) complete a Membership Application Form and forward to the Secretary of the Board of Directors, and be approved by the Board of Directors to become a Member; and
- (iv) pay any annual membership fee that has been established by the Board of Directors.

SECTION FOUR: MEMBERSHIP RESTRICTIONS

The following persons shall not be eligible to be a Member of the Corporation:

- (i) any employee of the Corporation.
- (ii) any past employee of the Corporation, until two (2) years after ceasing to be employed by the Corporation.
- (iii) any person who has a direct or indirect interest in a contract with the Corporation for the purchase of goods or services or other relationship with the Corporation that creates a conflict of interest or the appearance of a conflict of interest, until two (2) years after the expiry or early termination of such arrangement.
- (iv) any person employed by any union representing some or all of the employees of the Corporation; and/or
- (v) any person who has a legal action pending against the Corporation or who has had a legal action against the Corporation.

SECTION FIVE: MEMBERSHIP RIGHTS

Except as otherwise provided in the By-laws, Members of the Corporation have the right to:

- (i) receive notice of all meetings of the Members.
- (ii) attend all duly constituted meetings of the Members.
- (iii) be entitled to one (1) vote at all meetings of the Members of the Corporation including a proxy vote at the annual meeting of the Members of the Corporation.
- (iv) participate in decisions of matters properly before the Members of the Corporation; and
- (v) be eligible for election or appointment to the Board of Directors within the provisions of the By-laws of the Corporation.
